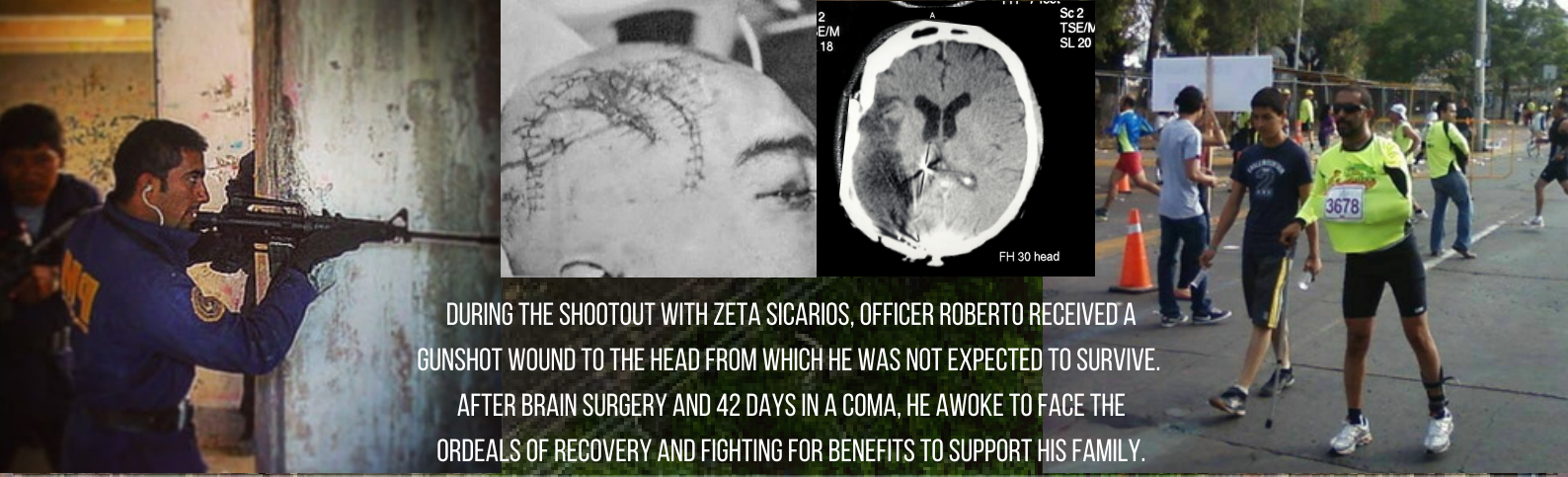


JESUS AND ROBERTO JOINED THE MUNICIPAL POLICE DEPARTMENT AT A YOUNG AGE WITH THE INTENTION TO PROVIDE THEIR FAMILIES THE NECESSARY SUPPORT FOR A BETTER FUTURE.

AFTER YEARS OF PREPARATION AND TRAININGS, THEY SERVED IN ELITE POLICE SWAT TEAMS, ACTIVELY ENGAGED IN OPERATIONS AGAINST THE DRUG CARTELS IN CENTRAL MEXICO: THE G.E.R.I AND THE G.E.T TEAMS.

IN JUNE 2009, THEY WERE CHECKING A REPORT OF ARMED MEN AT A BUILDING WHEN ASSAILANTS OPENED FIRE AND LOBBED GRENADES AT THEM. THE ENCOUNTER BETWEEN THIS TACTICAL GROUP AND MEMBERS OF "THE ZETAS" LEFT TWELVE CARTEL GUNMEN DEAD, A WOUNDED POLICE OFFICER, BUT EIGHTEEN SURVIVORS.

THIS EVENT REPRESENTS ONE OF THE MOST RELEVANT VICTORIES FROM THE POLICE FORCE AGAINST THE CARTELS.



DURING THE SHOOTOUT WITH ZETA SICARIOS, OFFICER ROBERTO RECEIVED A GUNSHOT WOUND TO THE HEAD FROM WHICH HE WAS NOT EXPECTED TO SURVIVE. AFTER BRAIN SURGERY AND 42 DAYS IN A COMA, HE AWOKE TO FACE THE ORDEALS OF RECOVERY AND FIGHTING FOR BENEFITS TO SUPPORT HIS FAMILY.

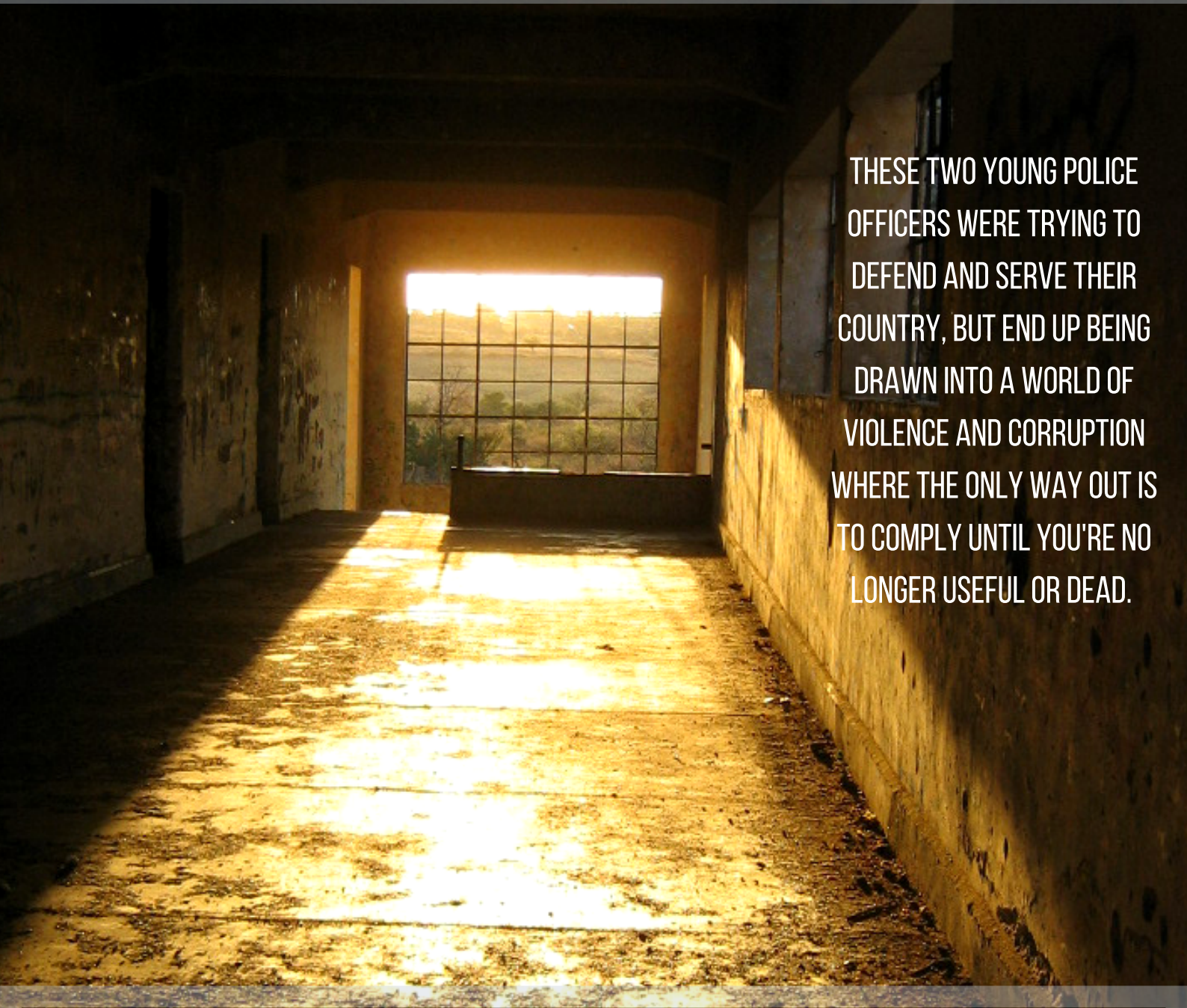


THE LOCAL GOVERNMENT DENIED ANY COMPENSATION AND LEFT HIM ALONE IN THE FIGHT FOR SURVIVAL. BUT HIS DREAM TO CONTINUE SERVING HIS COUNTRY ALLOWED HIM OVERCOME ALL THE OBSTACLES. WITHOUT GOVERNMENT AID, ROBERTO RECOVERED HIS MOTOR ABILITIES WITH ONLY HALF HIS BRAIN MASS, AND ACHIEVED INTERNATIONAL MEDALS AS AN ATHLETE FOR THE PARALYMPIC GAMES. ROBERTO IS ATTENDING LAW SCHOOL, AND IS THE PROPOSER OF A LEGAL INITIATIVE THAT GUARANTEES BENEFITS TO POLICE OFFICERS WHO ARE VICTIMS OF ATTACKS DURING SERVICE. THIS SECOND CHANCE TO LIVE ALSO MOTIVATED HIM TO TAKE CARE OF OTHER OFFICERS UNDER RECOVERY GIVING LIFE TO "ZAPATITO", A CHARACTER THAT HELPS HIM ON HIS MISSION TO PROVIDE EMOTIONAL SUPPORT TO OTHER FALLEN HEROES.



OFFICER JESUS HELPED LIFT THE LIFELESS BODY OF ROBERTO TO SAFETY DURING THAT FATEFUL SHOOTOUT AND CONTINUED TO WORK WITH THE POLICE UNTIL THE THREATS FROM THE CARTELS AND CORRUPTED COLLEAGUES. HE HAD TO FLEE TO THE U.S, WITH HIS FAMILY AND CLAIM ASYLUM BEFORE THEY ENDED UP AS ANOTHER STATISTIC ON THE WAR OF DRUGS.

THESE TWO YOUNG POLICE OFFICERS WERE TRYING TO DEFEND AND SERVE THEIR COUNTRY, BUT END UP BEING DRAWN INTO A WORLD OF VIOLENCE AND CORRUPTION WHERE THE ONLY WAY OUT IS TO COMPLY UNTIL YOU'RE NO LONGER USEFUL OR DEAD.
